Terms and Conditions:

- 1. Duration: The duration of the training workshops will be as per annexure 1.
- 2. Workshop Topics: The workshop will cover topics related as per the annexure 1.
- 3. Resources and Facilities: First party will provide the necessary resources and facilities required for the smooth conduct of the workshop. This may include classrooms, audio-visual aids, laboratory facilities, internet and any other necessary infrastructure.
- 4. Trainers: Second Party will assign qualified trainers who have expertise in the workshop topics. These trainers will be responsible for delivering the training sessions and providing necessary guidance and support to the participants.
- 5. Participants: First Party will identify and invite suitable participants for the workshop from its student body or any other relevant target audience. The number of participants will be determined by mutual agreement between both parties.
- 6. Marketing and Promotion: Both the parties will collaborate on marketing and promotion efforts for the workshop. This may include online and offline promotional activities such as social media campaigns, flyers, website announcements, etc.
- 7. Certification: Second Party will issue Hardcopy certificates of completion to the participants upon successful fulfillment of the workshop requirements.
- 8. Recruitment & Placement: Second party will register the trainees/participants for Recruitment and Placement purposes, free of cost.
- 9. Financial Arrangements: The financial arrangements, including any registration fees or cost-sharing agreements, will be mutually agreed upon by both parties which is in the ratio of 80:20.

- 10. Project Report: Second Party. will be responsible for preparing Projects through students in A1 & A2 Formats prescribed by the university.
- 10. Exercising Authority: On behalf of the first party **Prof. Akansha Arora**, HOD, Department of Commerce, SHGC and on behalf of the Second Party, **Mr. Rahul Jain/ Mr Gautam Jain** will act as the exercising authorities, for operating the various provisions of this MoU on behalf of their respective organizations. - 11. Confidentiality: Both parties agree to maintain the confidentiality of all confidential information shared during the collaboration and not to disclose it to any third party without prior written consent.
